<b>Returns:</b> No returns without authorization. Authorized product returns are subject to a 30% restocking fee. Return shipping is at the customer's expense, and any product that is returned damaged will be charged to the customer. Claims for returned goods may not be deducted from invoices, nor should payment of invoices be withheld. A separate credit memo will be issued.							
<b>Damage Claims:</b> Conifer Specialties is not responsible for damage to or loss of merchandise after it is consigned to the shipper. Claims for lost or damaged merchandise must be noted with the shipper at the time of delivery, preferably in writing on the bill of lading.
